On the recommendation of Collector-turned-Rajya Sabha MP Ajit Jogi, Congress gave the ticket from number four Assembly to Mohammad Iqbal Khan. Due to the condidature of Mohammad Iqbal Khan, there was polarization in candidature of Mohammad Iqbal Khan, there was polarization in the entire western Indore. In the result, Kailash Vijayvargiya won from assembly constituency number 4 by around 27000 votes without campaigning. Kailash Vijayvargiya could not actually campaign because his father passed away the day after submitting the nomination form. Laxman Singh Gaur, who had worked with Kailash Vijayvargiya in the Akhil Bharatiya Vidyarthi Parishad, handled the entire election campaign. Laxman Singh Gaur became established in the entire assembly constituency with this election. In the 1993 assembly elections held after 1990, BJP shifted Kailash Vijayvargiya to area number 2. In 1993, Laxman Singh Gaur, who was popular in the area by the name of Lakhan Dada, was released from here. Laxman Singh Gaur won that election easily by more than 30,000 votes. After this, in 1998 and 2003 also, Laxman Singh Caur, won, and scored a hot trick of becoming MIA. He Gaur won and scored a hat-trick of becoming MLA. He unfortunately died in a road accident in February 2008. After the generation of leaders like Rajendra Dharkar, Shrivallabh Sharma, Nirbhay Singh Patel, Narayan Rao Dharam, Satyawan Singhal, Utsav Chand Porwal, leaders like Kailash Vijayvargiya, Laxman Singh Gaur, Prakash Sonkar, Sumitra Mahajan, Gopi Krishna Nema led the BJP organization to Indore city. They played an important role in making it invincible. After 1990, the influence of Sangh Parivar also expanded tremendously in Indore district. Its political impact was also felt not only in Indore district but in the entire Malwa and Nimar region.

## Two children get new lease of life in AIIMS

Children suffering from heart disease were cured without surgery

Under the guidance of Professor Dr. Ajay Singh, Executive Director of AIIMS Bhopal, for the first time, a rare and complex congenital heart disease in pediatric patients was cured without surgery using the Nitinol device.

In the first case, a 1year-old girl who weighed only 6 kg had difficulty in breathing, was not able to drink milk and along with weight loss, she was also facing the problem of strain. echocardiography revealed that he had a rare

called aortopulmonary window (0.1 to 0.6T CHD). The AP window is a hole between two large vessels of the heart. If this hole in the heart is not closed time, the patient's life becomes in

to the heart through a vein from the patient's waist and the ĥole was closed

#### Three year old child diagnosed with septal defect

In the second case, a 3year-old boy weighing 12 kg was diagnosed with a large ostium secundum atrial septal defect of 25 mm size, who was referred to AIIMS from another hospital for surgical closure. But here the team of cardiology doctors after examination without operation and found it suitable for percutaneous transcatheter closure. In this case the child was successfully managed with a 28 mm button-like nitinol device and the child did not require surgery.
