BJP registered major gains in panchayat polls: Ramchander

Hyderabad: BJP Telangana State President N Ramchander Rao on Friday claimed that the party had recorded significant gains in the recent local body elections across Telangana, reflecting growing public support for the party and the governance model of Prime Minister Narendra Modi. Addressing a meeting of Sarpanches, Upasarpanches and ward members of Nirmal district, Rao said BJP-backed candidates have won 103 of the 181 Gram Panchayats in Mudhol Assembly constituency, over 80 of the 128 Gram Panchayats in Nirmal district, and 32 Sarpanch posts in Khanapur constituency.

Kochi: A departmental investigation has been ordered against K.G. Pratap Chandran, a police officer suspended following allegations that he assaulted a pregnant woman at a police station. The action comes after video footage showing the incident sparked public outrage. The incident reportedly took place on June 20, 2024, when Shaimol (41), wife of businessman Benjo Baby, visited Ernakulam North Police Station after her husband's detention in a case involving two men evading arrest. The family claims that the officer physically assaulted Shaimol despite knowing she was preg-

ED seizes assets, probes Rs 57 cr fraud linked to secessionist activities in Manipur

New Delhi: The Enforcement Directorate's Imphal Sub Zone conducted search operations re-cently at five residential locations in Imphal belonging to directors of the Salai Group, leading to the seizure of three cars and property documents worth Rs 10 crore. The searches, assisted by 30 CRPF personnel, targeted premises linked to N. Samarjit Singh, N. Biswajit Singh, A. Deepanand, E Brojendro Singh, and T. Tikendra Singh. Authorities also seized five mobile phones containing incriminat-ing data related to the group's companies. The ED's investiga-tion originates from a Manipur Police FIR against individuals, including Yambem Biren and Narengbam Samarjit, who allegedly declared independence from India as part of a "Manipur

ED makes fresh arrest in Chhattisgarh liquor scam case

State Council."

New Delhi: The Enforcement Directorate (ED), Raipur Zonal Office, on Friday said that they have arrested Saumya Chaurasia on December 16 in the Chhattisgarh liquor scam case. An ED official said Chaurasia was produced before a Special PMLA Court in Raipur, which remanded her in ED custody for three days. The ED initiated an investigation on an FIR registered by ACB-EOW, Raipur, Chhattisgarh, under various sections of the IPC, 1860, and the Prevention of Corruption Act, 1988. Police investigation has revealed that the Chhattisgarh liquor scam caused a massive loss to the state exchequer and generated more than Rs 2,500 crore of proceeds of crime (POC), enriching the beneficiaries through scheduled offences.

Operations against militants continue in Manipur, IED recovered

Imphal: Security Forces intensified searches around Churachandru district from where coordinated attacks launched by Kuki militants on internally displaced persons. So far no arrests have been made after Kuki armed militants launched attack on a village in Bishnupur district using bombs. An FIR has been filed so far by Manipur Police. Security Forces on Thursday recovered sixteen abandoned ANFO (paste type) IED at Lungdeiphai Leinom village junction, Kangvai area under Churachandpur-PS, Churachandpur district. The IEDs have since been neutralized by bomb disposal squad. Security Forces also destroyed a total of 119 acres of poppy plantation at LM Block, Yaolen Chepu and Lamlai Chingphei area.

India, Bangladesh must not allow any forces to disrupt relations: Saran

In the wake of mob attacks on Indian missions in Bangladesh, Pankaj Saran, former Deputy National Security Advisor, has said that India and Bangladesh "must not allow any forces to disrupt" what he described as a "natural relationship" between the two countries.

In an exclusive interview to UNI, Saran, who served as India's High Commissioner to Bangladesh during a crucial phase in the neighbouring country's political life, cautioned that "inflammatory actions and statements only serve to vitiate the atmosphere." He was referring to remarks made by various student leaders in Bangladesh that have been critical of India and against Indian

He also said New Delhi would closely "watch the situation to ensure that no harm comes to the Indian High Commission or to Indian diplomats" posted in the neighbour-

ing country.

Bangladesh witnessed a night of widespread violence from late



Thursday into Friday morning, as coordinated mobs went on a rampage across Dhaka and several other cities following the death of Sharif Osman Hadi, a key leader of the Inqiah Mangha mayarana in a languar and a languar a lab Mancha movement in a hospital

The unrest has raised serious concerns over internal security, press freedom, and the safety of diplomatic missions in the country.

Among the targets were Indian Missions in Khulna and Chattogram, besides political leaders and journal-

ists who have been critical of the current regime. Also targeted were offices of newspapers – Daily Star and 'Prothom Alo' – and liberal cultural organisation 'Chayanaut'. Slogans such as "Boycott India," "Burn Awami League dens," and "Hadi's blood will not go in vain" echoed through Expressing hope that "good sense will prevail," Saran underlined that

while protests are an integral part of any democracy, they must be "conducted strictly within the bounds of The former Indian diplomat and

strategist added that a "vast majority of people in Bangladesh want a normal relationship with India", which, he said, has always been the real strength of bilateral ties.

Commenting on reports of Pakistan, Turkey and China sending various delegations to Bangladesh, including Pakistani military and intelligence delegations, Saran noted the current interim administration in Dhaka has initiated contacts with

security interests.

"We will have to watch closely the direction and intention behind these interactions," he said. Saran noted that it was no secret that India's relations with Pakistan remain fraught with tension. "We do not regard Pakistan as a reliable neighbour. We see it as a neighbour that works against India," he said, adding that he hoped the interim government in Bangladesh would keep these sensi-

He said that if Pakistan and Bangladesh wished to re-establish stronger contacts, that in itself was not an issue, "as long as it is not directed against India or against India's

Speaking of the planned elections in Bangladesh in February next year, Saran, who also heads the influentia strategic think tank NatStrat said, "all well wishers hope the elections proceed .., they are inclusive, free and fair" and added that after all the student protests in July-August 2024 which eventually led to Sheikh Hasina leaving Dhaka was all "about democracy."

ED to probe money-laundering aspects in Sabarimala gold smuggling case

Thiruvananthapuram: The Enforce ment Directorate (ED) has initiated steps to investigate the money-laundering aspects of the alleged gold smuggling linked to the Sabarimala temple, following directions from a Vigilance Court in Kollam on Friday.

The court ordered the Special Investigation Team (SIT), which is probing the case, to provide the ED with certified copies of key documents, including FIRs, remand reports, seizure mahazars and witness

The ED had approached the court seeking access to the records to examine whether proceeds of crime were generated and laundered.

While allowing the request, the court made it clear that the ED's probe should be limited to offences under the Prevention of Money Laundering Act (PMLA) and should not interfere with the ongoing vigi lance investigation.

The case pertains to the alleged misappropriation and smuggling of gold removed during renovation works at the Sabarimala temple, including gold plating from sacred

When a counsel pressed for urgent listing, the CJI questioned whether those seeking listings were prepared to argue the matters during the vacation. "All those who are in the queue seeking listing, will you argue on Monday? We are ready to sit on Monday," he remarked.

Delhi Pollution: Govt to install air purifiers in 10,000 school classrooms

New Delhi (UNI)

In view of the rising pollution levels in the national capital, Delhi Education Minister Ashish Sood on Friday announced that the government will float a tender in the first phase to install air purifiers in 10,000 classrooms across government schools.

Addressing the media, Sood said the initiative aims to ensure a healthier environment for students. "Along with smart classes, children will now get 'pure air'. In the coming phases, air purifiers will be installed in every classroom of Delhi government schools in a phased manner," he said. Emphasising the government's commitment, the minister said the administration would not compromise on children's health.

"We do not want to play with our children's health, nor will we allow anyone else to do so," he added. Sood said pollution in Delhi is not a problem limited to No foul play behind **Zubeen Garg's death Guwahati:** While the Special Investigation Team (SIT) of the Assam po-

lice have filed chargesheet regarding the death of Zubeen Garg recently and named four accused for murder, the Singapore Police Force (SPF) have recently said that they do not suspect any foul play behind the death of the iconic singer. Garg died in Singapore on September 19 under mysterious circumstances triggering huge outcry in Assam with millions of people demanding justice for Zubeen Garg. The SIT of the Assam Police has so far arrested seven persons and recorded statements.

Migrant labourer from Chhattisgarh beaten to death, five held in Kerala's Walayar

Palakkad (UNI)

A 31-year-old migrant labourer from Bilaspur in Chhattisgarh was allegedly beaten to death in a case of mob lynching, after being accused of theft at Attapalam near Walayar, on December 17.

The deceased was identified as Ramnarayan Bhayar (31) of Bilaspur. Police have arrested five persons — Anu, Prasad, Murali, Vipin and Ananthan — from Attapalam in connection with the incident and registered a murder case under section of BNS 103 (2)

(culpable homicide). Walayar Inspector NS Rajeev said 10 more suspects have been taken into custody and their arrest would be recorded after receiving the postmortem reports.



All the arrested five youths were produced before the court on Friday and sent to judicial custody

The postmortem process was concluded at Thrissur Medical College Hospital, under the supervision of a Forensic surgeon on Friday. The report stated that Ramnarayanan suffered extensive injuries all over his body due to the alleged assault with sticks. Injuries were also found on his neck, hands and waist.

According to police, Ramanarayan had arrived at Walayar four days ago in search of a job at KINFRA park at Kanjikode, where his cousin Sasikanth works as a contractual employee in a local firm. Sasikanth told media that Ramnarayan had no criminal background and was wandering around at Mathalikadu near Attapalam as he did not know the route to Kanjikode, where his relatives were staying.
