Two tribals youth killed in bike accident at Wayanad

Wayanad: Two tribal youths were killed in a bike accident at Moolankavu, after their bike hit a milestone and fell into a gorge, while returning to their houses after watching a cinema from Sulthan Bathery, on Friday. According to police, the deceased were identified as Suneesh (24) and his friend Biju (22), both residing in separate Unnathi (hamlets) at Noolpuzha near Sulthan Bathery. The incident took place around 2300 hrs on Thursday, and the body was found by local residents in the morning at a plot along with their motor bike.

KTR challenges CM **Revanth Reddy for** by-elections

Hyderabad: BRS Working President KT Rama Rao (KTR) on Friday held a cordial meeting with newly elected BRS sarpanches from Sircilla district and launched a sharp attack on Chief Minister A Revanth Reddy, challenging him to face by-elections to prove his party's strength. Addressing the gathering, KTR said if the Chief Minister's claim that 66 per cent of the people are with the Congress was true, he should have the courage to ask the MLAs who defected from the BRS to resign and contest elections. "Let the people decide who they are with and what the real strength of each party is," he said.

NCP suspends student wing chief

Pune: The Nationalist Congress Party (NCP) Ajit Pawar faction on Friday suspended its student wing president Vishal More following his arrest in a drug trafficking case. More was arrested by the Mumbai Crime Branch in connection with the trafficking of MD (mephedrone) drugs from Savari village in Satara district. According to police, two people supplying drugs in Mumbai's Mulund area were detained earlier. During interrogation, they revealed that More was allegedly involved in supplying narcotics. Earlier, Shiv Sena (Thackeray faction) leader Sushma Andhare had made allegations linking Deputy Chief Minister Eknath Shinde's brother Prakash Shinde to the drug trafficking case.

She noted that the Constitution makers devoted an entire part of the Constitution to Services and Public Service Commissions, underscoring their critical role at the union and State levels.

Referring to the constitutional ideals of social, economic and political justice, the President said Public Service Commissions act as change agents in promoting equality and equity. She emphasised that integrity, sensitivity and competence of civil servants forming the "permanent executive" are vital for effective governance and implementation of people-centric policies. While gaps can be addressed through training, she said, lack of integrity is non-negotiable and may pose challenges that are impossible to overcome.

Amit Shah emphasizes need to setup robust port security framework



Union Home Minister Amit Shah has emphasized the need to establish a robust port security framework across the country, and directed that security measures should be implemented in a graded and risk-based manner, taking into account vulnerabilities, trade potential, location, and other relevant pa-

Shah convened a meeting for the constitution of a dedicated body, the Bureau of Port Security (BoPS), for the security of vessels and port facilities, which was attended by union Minister for Ports, Shipping and Water-ways and Minister of Civil Avia-

The BoPS shall also ensure timely analysis, collection and exchange of security-related information, with a special focus on cyber security, including a dedicated division to safeguard port IT infrastructure from digital threats.

To strengthen port security infrastructure, the Central Industrial Security Force (CISF) has been designated as a Recognised Security Organisa tion (RSO) for port facilities with the responsibility for undertaking security assessments and preparation of security plans for ports.

Uproar in Haryana assembly over 'Vande Mataram' debate

Chandigarh: Proceedings in the Haryana Assembly were repeatedly disrupted on Friday during the second day of the winter session as a debate on Vande Mataram triggered sharp political exchanges, leading to sloganeering, the naming of Congress legislators and physical scuffles between MLAs and marshals.

The controversy began after Zero Hour, when a ruling party MLA proposed a discussion on Vande Mataram and it was accepted by Speaker Harvinder Kalyan.

After lunch, Chief Minister Navab Singh Saini initiated the debate, describing the subject as significant for public awareness and youth education. As opposition members, led by former chief minister and Leader of the Opposition Bhupinder Singh Hooda, moved into the well of the House, the Speaker named nine Congress MLAs for violating Assembly rules and ordered their removal.

Poll win turns violent in Ludhiana Cops book 18 Cong workers after firing

Chandigarh (UNI)

Celebrations following the Block Samiti election results in Ludhiana spiralled into violence after clashes erupted between supporters of the Aam Aadmi Party (AAP) and the Congress, prompting police to register a case against 18 Congress workers for alleged involvement in firing and rioting.

Police officials said an FIR has been lodged at the Sadar police station against six identified individuals and 12 others who are yet to be identified.

The action was taken after circulating online videos showed armed confrontation and gunshots during the alterAccording to preliminary findings, rival groups engaged in heated arguments late at night, which quickly escalated into stone-pelting.

The situation deteriorated further when gunfire was allegedly opened, creating panic in the area. Police teams carried out raids overnight to trace and arrest those accused of firing.

Those named in the FIR include former sarpanch Jasvir Singh, Ajayvir, Udayvir, Tajinder Singh alias Laddi, Panch Pooja, Harpal Singh alias Babbu and others.

Officials said identification of remaining suspects is underway based on video evidence and local inputs.

Fact Check: No damage to Pathankot airbase

Open-source intelligence (OSINT) expert Damien Symon has debunked viral pro-Pakistan claims circulating on social media that alleged damage to Indian military infrastructure, including Pathankot airbase and Tibri cantonment, in Punjab, during Operation Sindoor in May 2025

The claims suggested that Pakistani strikes had damaged hangars at the Pathankot Airbase and the Tibri Cantonment heliport in Gurdaspur district of Punjab, allegedly forcing their reconstruction. To counter Pakistan's claims, Symon shared satellite imagery from May 2025 alongside the circulating posts, stating that there is no evidence to support Tibri military infrastructure during operation sindoor



these assertions. "Imagery is now being circulated to suggest that Pakistani strikes at Pathankot Airbase & Tibri Cantonment in Punjab, India, damaged hangars leading to their reconstruction — however data from May 2025 shows none of the suggested targets were ever damaged," Symon wrote on X.

He further flagged specific images shared on social media, including one dated November 28 that claimed a "new roof" had been installed at a damaged hangar in Pathankot, and another alleging reconstruction at the Tibri cantonment heliport.

Symon highlighted that the satellite imagery captured on May 11, 2025, shows the hangars intact, with no visible damage or reconstruction activity. "Hangar intact, no damage visible. Newer imagery shows no new roof has been installed," he noted.

Earlier, Symon had also countered misinformation claiming that the Radha Soami Satsang headquarters at Dera Beas in Punjab was a weapons storage facility targeted during the conflict. He clarified that the image being circulated as evidence of a Pakistani strike was "misleading" and actually "depicted the religious site," which remained undamaged during the India-Pakistan hostilities in May 2025.
